This scheme will damage tranquil green space along Riverside Avenue and will go through Holdenhurst Village Conservation Area, destroying Bournemouth's oldest building, the 500 year old Cob Barn.

The primary purpose of the scheme is to facilitate a large office development in the fields to the rear of the Royal Bournemouth Hospital, and the Council's own figures show that it will generate a significant amount of extra traffic, thus not easing congestion outside the Hospital, whilst adding to noise and air pollution and also harming wildlife.

Friends of Riverside and Holdenhurst Village Parish Meeting have written very strong arguments against the plans. To ensure that we achieve our aim of stopping this development, we ask you to write a short email or letter in objection.
